## What's On the Library Shelves?

Courtroom 302: a Year Behind the Scenes in an American Criminal Courthouse by Steve Bogira brings the reader to the Cook County Criminal Courthouse in Chicago to see the criminal justice system through the eyes of those who are enmeshed in its workings. The courtroom, the lockup, the jury room, the judge's chambers, and the spectators' gallery are all part of the tour.

Bogira presents a fascinating view of the busiest felony courthouse in America. A case that received a lot of public attention, what appears to have been a racially motivated brutal attack on a thirteen year old black boy by three white men, one the son of a noted Chicago mobster, is highlighted by Bogira. We, the readers, get to feel what it is like, behind the scenes, in this case and in many others that came to the Cook County Courthouse over a one-year period.

This book can be found on the shelves at **345.773 BOG** and may be checked out for three weeks.

Gary F. Cornelius talks about surviving in the world of corrections in his book <u>Stressed Out: Strategies for Living and Working in Corrections.</u> He talks about stress, what it is, and how it affects our health, about how events in the world of the correctional officer affect the stress level experienced, about coping techniques specific to correctional officers, and many other facets of stress for those who work in the field of corrections. Burnout is a part of most work environments and even more so in correctional services. Cornelius devotes a chapter to that subject as well as to such topics as managing time, relaxing both on and off the job, and a final chapter on stress and crisis.

A bonus in this slim volume of fewer than two hundred pages is Cornelius' inclusion of

information about a healthy diet, exercise, coping strategies, relaxation exercises, and other relevant helpful recommendations.

This book is located at **365 COR** and may also be checked out for three weeks.
