Even if the closest you get to police investigation is from a front-row seat in your family room, you will find the series of articles in the most current **[FBI Law Enforcement Bulletin](#)** (*January 2008*) very interesting. "Interview Clues" by Vincent A. Sandoval and "The Art of Investigative Interviewing: Countering the Lie of Omission" by Robert C. Wells address the importance of words and choice of words during the course of an investigative interview. Rather than lying outright, it is the omission of words and information as well as the particular words selected that often camouflage or completely hide the truth. The onus thus falls on the investigator to uncover what has been hidden.

[A Note to Instructors](#)

If there are any materials (books, videos, DVDs, reports, etc.) that you want your students to access easily, do consider placing them **ON RESERVE** at the library circulation desk. This status means the following:

- The instructor may specify for how long the item should remain **ON RESERVE**;
- The item can only be used in the library;
- The item may be used for a maximum of **two** hours and must then be returned to the desk; and
- The item may be removed for xeroxing by the instructor and then immediately returned to the circulation desk.
