### **Book Checkout and Return**

When borrowing books from the library, please be sure to follow these few simple guidelines for proper checkout.

1) See the librarian at the checkout desk to check your materials out electronically.

- 2) If the librarian is not available, please use the checkout log located on the circulation desk—there is one for **books** and another labeled for **journals**. When handling checkout in this manner, please follow up with the librarian by e-mail in order to determine the due date for your materials.
- 3) When returning materials, be sure to see the librarian. If the librarian is not available, please leave a note with the returned items to ensure that they are checked back in properly.
- 4) Please **DO NOT** return your books or other materials to the shelves where you took them. By leaving them at the circulation desk, I can keep track of what has been returned.
- 5) If you have left materials at the circulation desk and aren't certain that you followed the right procedures, give me a call or send me an e-mail. This will alert me to the fact that you have checked out or returned items, and I can take it from there.

### [NAMI of Baltimore](#)

**The following is excerpted and edited from a recent press release by the National Alliance on Mental Illness (NAMI)--Metropolitan Baltimore.**

A new book published by NAMI—Metropolitan Baltimore entitled [Beyond Punishment: Helping Individuals with Mental Illness in Maryland's Criminal Justice System](#) provides a first-of-its-kind, comprehensive practical guide to assisting individuals with mental illness who interact with Maryland's criminal justice system. Without proper intervention, mentally ill persons may cycle repeatedly through the criminal justice process, at great public expense and great trauma to the individual and the family.

Made possible by a grant from the Harry and Jeanette Weinberg Foundation, this book provides information and critical resources to family members and others concerned about people who are involved with the criminal justice system, whether in jail awaiting trial, in prison serving a sentence, or on probation or parole. It also discusses ways to help prevent a mental health crisis from leading to an arrest and subsequent involvement in the criminal justice system, as well as how to get mental health crisis services, including voluntary and involuntary evaluations.

The Maryland Division of Correction, as well as other organizations around the state, plans to

widely distribute copies of the book. NAMI—Metropolitan Baltimore will also distribute the book through its network of support groups, its assistance phone line, website, and other means.

The book provides important general information about Maryland's criminal justice system as well as local information about resources within Baltimore City and Baltimore County. It is designed to serve as a template that groups in other areas of the state can use with local information in their areas. The national NAMI organization also intends to make the book available to other NAMI affiliates outside Maryland, who could then customize the information to reflect their local criminal justice systems.

**NAMI Metropolitan Baltimore** is an independently incorporated, governed, and funded affiliate of NAMI Maryland and NAMI: National Alliance on Mental Illness and is regularly recognized as a leader in the areas of advocacy for mental illness issues and in the development of programs and outreach tools for a variety of audiences.
