Target – _____ (Scoring targets, area may not exceed 80 square inches. 80 square inches equals the 9 and 10 ring of a B-27 target)

Instructors – Attach list of instructors by name and certification numbers

Training – for each long gun authorized to use or carry consists of demonstrations to familiarize the officer with the nomenclature, operation, safety, care, and cleaning of the weapon

Qualification – _____ rounds (20 rounds minimum)

Scoring – 100% required

Required firing distances – (1) 25 yards; (2) two distances greater than 25 yards and less than 200; (3) 200 yards or greater.

Required percentages of rounds – minimum of 10% but not more than 30% from any above firing distances.

Maximum time

Course – 5 seconds per round at 25 yards or less. Seconds per round when firing between 25 and 200 yards shall be proportional to the distances and times allowed: 10 seconds per round when firing at 200 yards or greater.

Reloads – an additional 5 seconds may be added for each round of ammunition reloaded in a long gun with an integral magazine and also for reloading a gun with a detachable box magazine.

Required body positions – Standing, (unsupported); Standing (supported by a barricade); Kneeling or sitting (supported by a barricade or unsupported); and Prone.

Simulated Stress - At least one stage of course shall be fired after exercise to simulate stress.

Note where reloads or movement to a different firing position are in the course
