# USE OF FORCE COMPLAINTS REPORT

MSAR 13162

### 2022 REPORT TO THE STATE OF MARYLAND January 1 – December 31, 2022

Public Safety Article §3-514 requires law enforcement agencies to collect data of police officers' use of force and report to the Maryland Police Training and Standards Commission (MPTSC) the data, aggregated by numbers of complaints administratively charged, not charged, unfounded, and exonerated. This includes aggregated data of all use of force complaints and not just those considered serious officer-involved incidents.

#### **USE OF FORCE INCIDENTS**

The Maryland Police and Correctional Training Commissions (MPCTC) staff developed a reporting process for agencies to report this information. On January 10, 2023, agency heads were emailed an informational reporting guide and reporting link to a new Google Doc reporting system where the required data was entered by each agency and uploaded into a system maintained by staff of MPCTC. Agencies were required to report the number of events for the following during calendar year 2022:

(1) Number of use of force complaints administratively charged

(2) Number of use of force complaints not charged

(3) Of those NOT charged, number of complaints unfounded

(4) Of those NOT charged, number of complaints exonerated

(5) Number of complaints pending

#### 2022 LAW ENFORCEMENT AGENCY REPORTING

There were 157 agencies employing approximately 16,000 Commission certified police officers in 2022. However, not all of the agencies were identified as being required to comply with Public Safety Article §3-207(b)(1) as some of the agencies have employees who are certified as law enforcement officers by the Police Training and Standards Commission, but are not defined as law enforcement agencies under Public Safety Article §3-101(e). Therefore, a total of 136 agencies that were required to report use of force complaints were identified for the 2022 reporting year. All of the required agencies filed a report with the MPTSC.
